VJP Specialists and other staff may find it useful to be able to read, share, and refer to published research and other sources related to the stigmatization of justice-involved Veterans and policies, tools, and strategies to address it. This Resource offers (1) Tips on quickly locating the most recent published literature on these topics, and (2) ten suggested reference articles.

# **1. Quick Tips for Finding Journal Articles**

- Google Scholar is one easy way to look up journal articles. Type "**scholar.google.com**" into your internet browser to pull up the search engine (see image below).
- PubMed from the National Library of Medicine is another, focused more on health: "pubmed.ncbi.nlm.nih.gov" (see image below).
- At either, type in the key words you are looking for to get a list of articles. Click on each entry to read the abstract; for some you can access full text.
- Consider using "boolean operators" to refine what your search will return; see details below.
- To access advanced search options, such as specifying date range, click on the stack of three lines ≡ in the upper left of the Google Scholar search screen, or the word "Advanced" under the search line on the PubMed search screen.

### **Boolean Operators**

 These are words or symbols used to combine or exclude keywords in a search. Below are a few common and helpful boolean operators.

Boolean Operators	Example
AND (limits results to both)	Veterans AND Justice Involvement (search will return only results containing <i>both</i> veterans and justice involvement)
OR	Veterans OR Justice
(one term OR another)	(search will return results that contain anything veteran related <i>or</i> justice related)
" "	"Justice Involved Veterans"
(exact phrase)	(search will return only results containing this <i>exact</i> phrase)
